ARTICLES OF ORGANIZATION

OF

LAND GROVE ASSOCIATES, L..L.C.,

a Florida Limited Liability Company



The undersigned, being a Member and the Manager of a limited liability company to be organized under the Florida Limited Liability Company Act, adopts and submits the following Articles of Organization for such limited liability company:

Article I COMPANY NAME

The name of the limited liability company (the "Company") shall be LAND GROVE ASSOCIATES, L.L.C.

Article II PRINCIPAL PLACE OF BUSINESS

The initial mailing address and street address of the principal office of the Company shall be 756 Brentwood Point, Naples, Florida 34110.

Article III REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered agent of the Company is 756 Brentwood Point, Naples, Florida 34110, and the name of the initial registered agent at such address is Dennis J. Lynch.

Article IV ADMISSION OF MEMBERS

Initially, the Company shall have THIRTEEN (13) Members. The Members of the Company may admit new members to the Company by vote of a majority in interest of the Members or by reason of a transfer of a membership interest in whole or in part, as more fully described in and subject to the terms, conditions and consent requirements set forth in the Regulations of the Company. Newly admitted members shall have all the rights and privileges as set forth in the Regulations of the Company.

Article V EFFECTIVE DATE

The Company's effective date of existence shall begin on June 1, 1999.



Article VI DURATION

The Company's duration shall be perpetual. Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member, or any other event that would terminate the continued membership of a Member in the Company, the remaining members shall have the right to unanimously agree to continue the business of the Company provided there are at least two (2) remaining Members.

Article VII ADOPTION OF REGULATIONS

The initial Regulations of the Company shall be adopted by the Company's initial Members. The Regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.

Article VIII MANAGER

The company will be managed by a Manager who shall be designated, appointed or elected as more fully described in the Regulations. The initial number of Managers of the Company shall be one (1). The number of Managers may be increased or decreased in accordance with the terms of the Regulations. The name and business address of the person who shall serve as Manager until replaced in the manner set forth in the Regulations is: **Dennis J. Lynch**, 756 **Brentwood Point**, **Naples**, **Florida 34110**.


