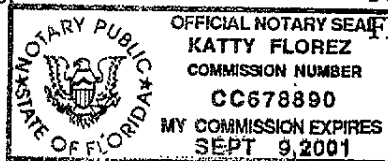

These Articles of Organization of a Limited Liability Company under Florida Statutes Chapter 608 are made and entered into as of the 22nd day of June, 1999.

ARTICLE I

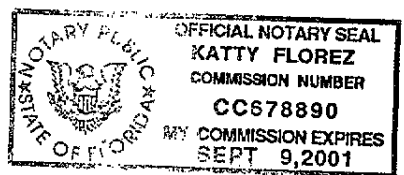
