ARTICLE V - CONTINUED

(D) THE NEW MEMBER SHALL RECEIVE A MUTUALLY AGREED UPON PORTION OF THE LLC OWNERSHIP AND AS DICTATED BY THE FLORIDA LIMITED LIABILITY COMPANY ACT.

(E) THE NEW MEMBERS SHALL NOT BE ASSIGNABLE, SALEABLE OR OTHERWISE TRANSFERABLE IN ANY FORM WITHOUT THE CONSENT OF BOTH MANAGERS. THE MANAGERS RESERVE THE RIGHT TO PURCHASE THE MEMBER'S SHARE AT A PREVIOUSLY AND MUTUALLY AGREED UPON PRICE BEFORE MEMBER CAN SELL TO ANOTHER PROSPECTIVE BUYER.
