ARTICLES OF ORGANIZATION

OF

1510 S. TUTTLE, L.L.C., A FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I

NAME

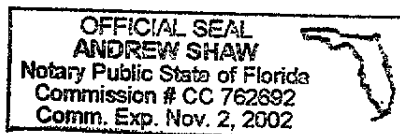
