**ARTICLES OF ORGANIZATION
OF

We, the organizers hereof, do hereby execute these Articles of Organization of Netcell, L.L.C. a limited liability company organized under, and pursuant to the Provisions of Chapter 608, Florida Statutes, 1987.

ARTICLE I - NAME

The name of limited liability company is: Netcell., L.L.C.

ARTICLE II - EXISTENCE

This limited liability company shall exist from the date of the filing of these articles of organization with the Department of State, Tallahassee, Florida, or such other offices thereof authorized to accept same, and for a maximum period of thirty (30) years from the date of filing hereof, unless otherwise terminated prior thereto in accordance with the law.

ARTICLE III - PURPOSE OF ORGANIZATION

ARTICLE VIII-CONTINUATION AFTER INVOLUNTARY TERMINATION

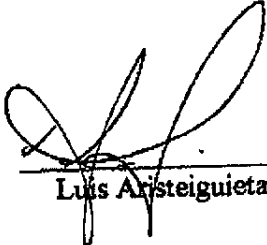

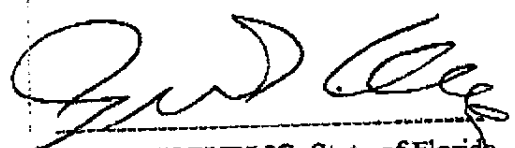

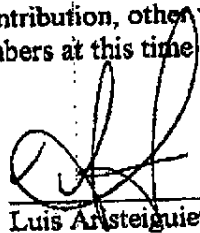
