

**ARTICLE I**

The name of this Limited Liability Company shall be Applied Building Technology, L.C.

**ARTICLE II**

This Limited Liability Company shall have a perpetual existence.

**ARTICLE III**

This Limited Liability Company is created for the purpose of transacting the business research, development, manufacturing, engineering, marketing, sales and property and business acquisition.

**ARTICLE IV**

The place of business of this Limited Liability Company shall be 16308 Gulf Boulevard, Suite 101, Redington Beach, Florida 33708, and such other place or places as the members from time to time shall determine.


