**ARTICLES OF ORGANIZATION FOR
TEETOGREEN GRAPHICS, LLC**

The undersigned, a natural person of at least 18 years of age, acting as organizer, hereby forms a limited liability company by virtue of the Florida Limited Liability Company Act, and adopts the following Articles of Organization for such limited liability company.

**ARTICLE I
Name**

The name of the Limited Liability Company is TEETOGREEN GRAPHICS, LLC.

**ARTICLE II
Principal place of business**

The principal place of business AND complete mailing address of the Limited Liability Company in Florida is 221 Pauls Drive, Suite A, Brandon, Florida 33511.

**ARTICLE III
Duration**

This Limited Liability Company shall dissolve and terminate thirty (30) years from the date of filing these Articles of Organization with the Florida Secretary of State.

**ARTICLE IV
Registered Agent**

The registered agent of this Limited Company in this state is Michael Klonecki. The business address of the registered agent is 221 Pauls Drive, Suite A, Brandon, FL 33511.

**ARTICLE V
Initial Manager**

The management of the Limited Liability Company shall be vested in its manager or managers. The affairs of the Limited Liability Company shall initially be governed by two (2) Managers. The number of Managers may be increased or decreased by agreement of the members, as is set forth more fully in the Operating Agreement of the Limited Liability Company. The managers shall be elected at each annual meeting of members. The Managers shall hold office for the term for which they are elected and until their successors have been elected and qualified. The names and addresses of the initial Managers who are to serve as Managers until the first meeting of the members or until their successors are elected and qualified are as follows:

ARTICLE VI

Purposes

The purpose for which Limited Liability Company is formed is to engage in any business that a partnership with limited partners may lawfully conduct.

ARTICLE VII

Members

There will be at least two members of this Limited Liability Company upon formation. The rights and duties of members of this Limited Liability Company shall be governed by these Articles and the Operating Agreement of the Limited Liability Company.

ARTICLE VIII

Admission of New Members

Additional members may be admitted upon unanimous written consent of all members.

ARTICLE IX

Admission of New Members

Upon death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event which may terminate the continued membership of a member ("Dissolution Event") in the Limited Liability Company, the business of the Limited Liability Company may be continued so long as there are at least two remaining members and all remaining members consent to the continuation of business. The Managers of the Limited Liability Company shall call a special meeting of members within 90 days after the Dissolution Event for purposes of determining whether the business shall be continued.

ARTICLE X

Transactions with Interested Managers

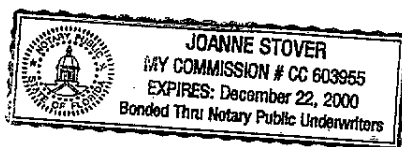
No contract or other transaction between the Limited Liability Company and its Managers or any other firm, association, or entity in which its managers are a director, manager or officer or in which they are financially interested shall be either void or voidable solely because of such relationship interest if:

- A. The fact of such relationship or interest is disclosed or known to the members of the Limited Liability Company and they authorize, approve, or ratify such contract or transaction by vote or written consent in accordance with the terms of the Operating Agreement; or
- B. the contract or transaction is fair and reasonable to the Limited Liability Company.

ARTICLE XI
Operating Agreement

To the extent not inconsistent with law or the terms of these Articles, the Operating Agreement of the Limited Liability Company shall govern the rights and duties of the members of the Limited Liability Company, and the relationships between the members.

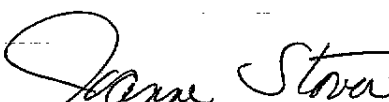
