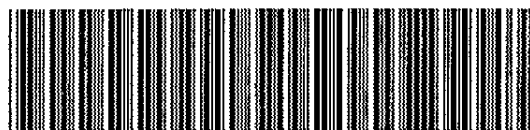

**ARTICLES OF AMENDMENT TO THE
ARTICLES OF ORGANIZATION OF

This Articles of Amendment to the Articles of Organization of OCALA RECYCLING, L.L.C. is made pursuant to Florida Statutes Section 608.411 (1999).

1. The Articles of Organization of OCALA RECYCLING, L.L.C. a limited liability company, filed on September 14, 1999, are hereby amended, to amend Article I which shall read as follows:

ARTICLE I

The name of the Limited Liability Company is FRIENDS RECYCLING, L.L.C.

3. This Amendment was adopted on April 25, 2003, and shall be effective when filed with the Department of State.

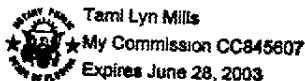
