ARTICLES OF ORGANIZATION

FOR

ZOLLER, NAJJAR & SHROYER, L.C.

The undersigned, acting as the agent duly authorized by the organizing Members of a Limited Liability Company to be formed under the Florida Limited Liability Company Act, as Amended (the "Act"), hereby forms a Florida Limited Liability Company (the "Company") pursuant to the Act, and hereby sets forth the following Articles of Organization (the "Articles"):

ARTICLE I

Name

The Name of the Company is ZOLLER, NAJJAR & SHROYER, L.C.

ARTICLE II

Commencement Date and Duration

The Company's existence shall commence on the date these Articles are filed with the Florida Department of State, and shall continue perpetually until dissolved in accordance with Section 608.441 of the Act.

ARTICLE III

The Company is organized to engage in the business of professional engineering, surveying and consulting and for any other business permitted under the Act.

ARTICLE IV:...

Principal Office

The street address of the principal office of the Company shall be 201 - 5th Avenue Drive East, Bradenton, Florida 34208, and the mailing address shall be Post Office Box 9448, Bradenton, Florida 34206.

ARTICLE V

Registered Agent and Office

The initial registered agent for the Company shall be THOMAS W. HARRISON, and the address of the registered agent for service of process shall be 1206 Manatee Avenue West, Bradenton, Floreda 34205.

ARTICLE VI

Management of Business

The Company shall be managed by a manager or managers. The managers shall have the right as may be set forth in the Regulations for the Company from time to time to elect officers for the Company. The qualifications for the managers and officers shall be specified in the Regulations. The managers and officers

will have the power and authority granted by the Members from time to time as provided in the Regulations.

ARTICLE VII

Admission of Additional Members

Additional Members may be admitted only by the affirmative vote of all of the other Members and upon terms and conditions established by the Members from time to time in their sole discretion.

ARTICLE VIII

Powers

The Company shall have all of the powers and authority set forth in Section 608.404 of the Act.

ARTICLE IX

Property

- (a) Ownership. All property originally paid for or transferred to the Company as contributions to capital by the Members, or subsequently acquired by purchase or otherwise from account of the Company, shall be the property of the Company.
- (b) <u>Title.</u> The title to all property of the Company shall be held in the name of the Company.
- (c) <u>Conveyances.</u> The right and manner to convey and encumber title to all real and personal property of the Company shall be as specified in the Regulations.

ARTICLE X....

Amendments

These Articles may be amended or restated at any time by a vote of the Members holding a majority in interest of the Company, and such amendment or restatement shall be filed with the Florida Department of State in accordance with the provisions of Section 608.411 of the Act.

ARTICLE XT.

Regulations

Regulations shall be prepared and adopted to govern the internal affairs of the Company containing such provisions as may be necessary, reasonable, or desirable, except that no provision of such Regulations may conflict with the provisions of these Articles unless permitted herein. The power to adopt aler, amend, or repeal the Regulations shall be set forth the Regulations.

ARTICLE XII

Contracting Debts

No debt shall be contracted nor liability incurred by or on behalf of the Company except as may be specified in the Regulations.

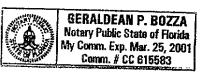
