ARTICLES OF ORGANIZATION

OF

BIRDIE INVESTMENT & TRADE LLC

A Florida limited liability company

- 1. The name of this limited liability company is **BIRDIE INVESTMENT & TRADE LLC** (the "Company").
- 2. The Company is being formed for the following purposes:
