

ARTICLES OF AMENDMENT

ARTICLES OF INCORPORATION

OF

PAYAS, PAYAS & PAYAS, P.A.

Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned President of Payas, Payas, & Payas, P.A., a Florida Corporation (the "Corporation"), for and on behalf of the Corporation does hereby execute these Articles of Amendment to the Articles of Incorporation of the Corporation.
