Your office returned my form stating that "the report has not been filled and a copy is being returned for the following correction (s)" : "The registered agent must have a Florida street address."

Please note that I have a registered business in both Florida and Ohio. I operate both businesses at different times of the year. My Florida business address is listed on the form. It is:

17 Bluebill Ave, #803, Naples, FL 34108.

The reason that I put my Ohio address on the form is that ALL mail from Ohio is sent weekly to my Florida address by priority mail when I am in Florida.

However many of the correspondence from your departments is marked "Do not forward", and thus I never receive it when I am operating in Ohio. Your form is marked "2. Principal Place of Business" and, "3. Mailing Address" . I do business equally in both states! If I mark Florida as my principal place of business and your department sends me mail when I am not there, I many times never receive it and thus would be considered delinquent in filing forms or making payments!!! This is a real "CATCH 22".

I tried to redo your form by changing entries to reflect my Florida address, You sent me no new form to complete, so I apologize for the condition of the current form. If this is not satisfactory, please send me a new form to complete.
