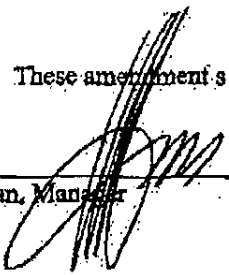
1. Madonna Coffman has resigned from her positions as a Manager of the Company.
