## PLAN OF MERGER

The following plan of merger, which was adopted and approved by each party to the merger in accordance with Sections 607.1108, 607.1109 and 607.11101 Florida Statutes and Sections 450.4705a and 450.4703, Michigan Compiled Laws.

**FIRST:** The exact name, form/entity type and jurisdiction of each **merging** party are as follows:

**FOURTH:** The manner and basis of converting the interests, shares, obligations or other securities of each merged party into the interests, shares, obligations or other securities of the survivor, in whole or in part, into cash or other property are as follows:

At the effective time of the merger, the stock in Hobe Sound Mobile Home Park Associates, Inc. shall be cancelled and the sole shareholder of Hobe Sound Mobile Home Park Associates, Inc. shall receive 0% additional membership interest in the Surviving Company. The limited liability company was formed in 1998. At that time the sole shareholder of Hobe Sound Mobile Home Park Associates, Inc. received a 44.5% membership interest in the Surviving Company in consideration of the future merger.

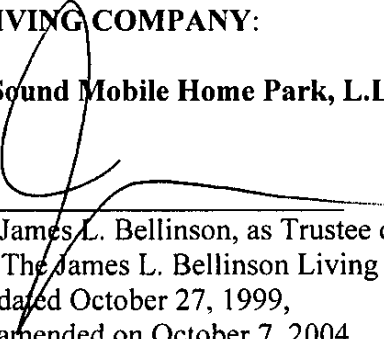

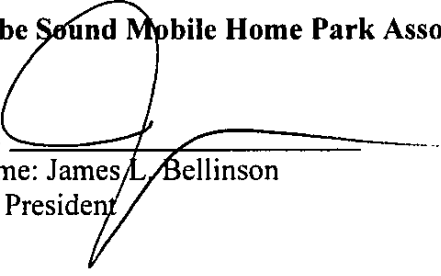
