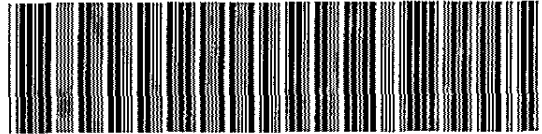

SECOND: The date of adoption of this Amendment was: February 7, 2005.

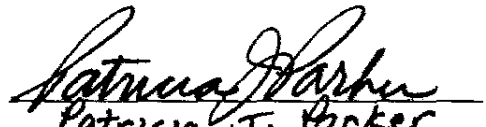

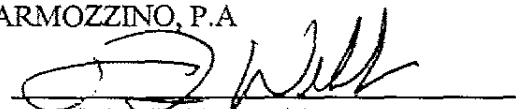
