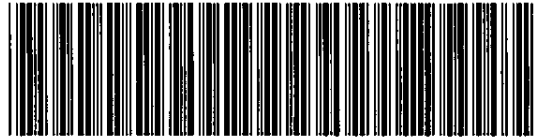

AMENDMENT: The amount of Capital Stock shall be Ninety thousand (\$90,000.00) and no cents.



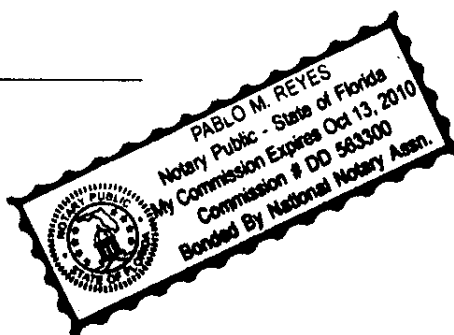
ARTICLE IV


