

PMC INVESTMENT CORPORATION, a Florida corporation under its corporate seal and the hands of its President, Jan F. Salit, and its Assistant Secretary, Barry N. Berlin, hereby certify that:

I

PMC INVESTMENT CORPORATION was organized under the laws of the State of Florida by Articles of Incorporation filed May 4, 1986.

II

The sole shareholder and a majority of the board of directors of said Corporation, at a special meeting, at which a quorum was present, duly called and held on March 26, 2014 adopted the following resolution relating to an Amendment to the Articles of Incorporation:

1. The Articles of Incorporation are amended by striking therefrom Article III, in its entirety, and inserting in place thereof the following:

THIRD: The Corporation has the authority, acting through its board of directors, to issue not more than 7,500 shares of a single class having a par value of \$1.00 per share which shall be referred to as "common shares." The common shares (a) shall be one and the same class, (b) shall have unlimited voting rights (with each share having one vote on each matter submitted to shareholders for vote), (c) shall have equal rights of participation in dividends and other distributions, and (d) shall be entitled to receive the net assets of the corporation ratably upon dissolution.
