## ARTICLES OF AMENDMENT

97 FEB 27 PH 12: 44 KNOW ALL MEN BY THESE PRESENTS: The undersigned, as Aresident and Secretary of ELIZABETH PROPERTIES, INC., a Florida corporation, do hereby certify that the following amendment to the Articles of Incorporation was approved by a majority vote of the shareholders entitled to vote and by a majority vote of the directors of said entitled to vote and by a majority vote of the directors of said corporation on the in day of Jana, 1996, and that the number of votes cast for the amendment by the shareholders and directors respectively was sufficient for approval by such voting group:

## \*AHENDMENT TO ARTICLES OF INCORPORATION

Article IV, CAPITAL STOCK, is hereby deleted and is replaced by the following:

### ARTICLE IV

The corporation is authorized to have outstanding two (2) classes of stock, designated as voting common stock and non-voting common stock. The maximum number of shares of common stock which the corporation is authorized to have outstanding is Ten Thousand (10,000) shares having a par value of \$1.00 per share. Holders of voting common stock are entitled to vote on all questions required by law on the basis of one vote per share of voting common stock, and there shall be no cumulative voting. Holders of voting and non-voting common stock shall have preemptive rights to subscribe to the corporation's securities, but holders of non-voting stock shall not have preemptive rights to subscribe to voting stock."
