ARTICLES OF AMENDMENT OF INVESTMENT RECOVERY CORPORATION
CHANGING THE NAME OF THE CORPORATION TO INTELLEX CORPORATION

PURSUANT TO SECTION 607.1006 OF THE FLORIDA BUSINESS CORPORATIONS ACT, THE
UNDERSIGNED CORPORATION ADOPTS THESE ARTICLES OF AMENDMENT:

FIRST: These Articles of Amendment of Investment Recovery Corporation are to change the name of
the corporation to Intellex Corporation. The new name of the Corporation, Intellex Corporation, satisfies
the requirements of Florida Statute 607.1007.

SECOND: This amendment, which approves the change of name to Intellex Corporation, and,
furthermore, formalizes the name change of the corporation to Intellex Corporation, previously made by
Articles of Amendment of Investment Recovery Corporation executed May 10, 2000, and the Restated
Articles of Incorporation of Intellex Corporation, executed May 10, 2000, both of which were filed with
the Florida Secretary of State on May 16, 2000; and both of which are formally ratified herein.

THIRD: This amendment was approved by the shareholders on October 26, 2000. The number of votes
cast by the shareholders was sufficient for approval.
