Enclosed is the completed Reinstatement Form for our Corporation, D & D Enterprises of Sanford, Inc.. We are at a loss as to why we did not get this renewed on a timely basis as we did for 12 years prior. This company is a small company that we operate on a part-time basis out of our home.

We moved a little over 2 years ago and there is where we feel the problem is. The Principal's Address is correct, however my address as Registered Agent was not changed. I am enclosing a copy of the 2000-Report (mailing cover) that was sent to the correct address. We returned the completed form to you on April 26, 2000. This shows that the correct address was on our file at that time. In reading the FAQ's I noted that a "Notice of Administrative Dissolution" will be sent as a 60 day notice. We did not receive this or the 2001, and 2002 annual renewal forms. As a part-time business I guess we did not file our 2001 and 2002 return because we did not receive the booklet of forms to remind us. I realize this is our mistake, but we are "older folks" and respond to things we receive on a timely basis. We have made monthly sales tax reports on time, and filed our annual tax returns also on a timely basis.

We would appeal to you for a *waiver of the penalty fee* for not filing on time for these 2 years. We desire to be current as of 2003. I am a little confused as to how much to send you. I do not want to be presumptive that we would receive the waiver however I am enclosing a check for \$458.75. This would be for the 2001, 2002, 2003 renewal fee and \$8.75 for a certificate that we are current. If we do not receive the waiver, please advise us as to the amount and we will decide if we can afford to do so. It may well be more than we can afford.
