It has come to our attention that above referenced annual report was not filed by the above referenced corporation. Included please find a copy of the annual report as well as a check in the amount of \$150.00 for the annual filing fee. We are respectfully requesting to pay the original filing fee amount instead of the delinquent fee amount due to reasonable cause as follows:

(1) The company evidently did not receive the first notice due to the sale of the business during the early part of 2000 and the changeover in ownership as well as the confusion surrounding the same.

(2) The company is a small bar b que restaurant that has been sold and cannot afford this large additional amount due.

(3) As soon as the corporation realized the annual report had not been filed they immediately contacted an accountant, prepared the form, and sent the original amount due.

(4) The taxpayer was out of the business and the sole shareholder obtained another job during this period. The taxpayer now has his wife checking all correspondence on a regular basis to ensure this problem doesn't continue.
