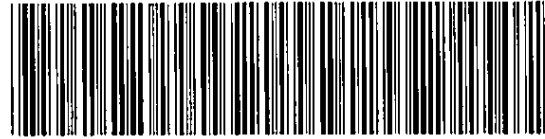

Article I

Name

The name of this Corporation is STEPP'S TOWING SERVICE
TAMPA, INC.

Article II

Duration

The Corporation shall have perpetual existence.

Article III

Purpose and Principal Place of Business

Purpose. The general purposes for which this Corporation is
organized are:

1. To engage in the general business of towing and
storage of motor vehicles, and to engage in any other trade or
business which can, in the opinion of the Board of Directors of this
Corporation, be advantageously carried on in connection with or
auxiliary to the foregoing business.
2. To transact any or all lawful business for which
corporations may be incorporated under the laws of the State of
Florida.
3. To do everything necessary and proper in
accomplishing the foregoing and to do anything incidental to the
foregoing, all as authorized and not forbidden under the laws of the
State of Florida.
4. To possess and have the authority to exercise any
and all powers allowed by the laws of the State of Florida.

Article IV

Capital Stock

The amount of capital stock authorized shall consist of 7,500 shares of the common voting stock having a par value of \$1.00 per share, payable in lawful money of the United States of America or in property, at a just valuation to be fixed by the Board of Directors of this Corporation. The capital stock of the Corporation may at any time be increased or decreased as provided by the laws of Florida.

Article V

Preemptive Rights

Every shareholder of this Corporation, upon the sale for cash of any new stock of this Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata shares thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

Article VI

Registered Office and Agent

Section 1. The undersigned incorporator of this Corporation, desiring to organize under the laws of the State of Florida, with its principal place of business located in the City of Tampa, State of Florida, has named David P. Rankin, Esquire, as its agent to accept service of process within this State.

Section 2. 4627 W. Cypress Street, Suite 412, Tampa, Florida 33607, is hereby designated by said incorporator as the Registered Office of the Corporation in the State of Florida, and David P. Rankin, Esquire, is hereby named as the Registered Agent of the Corporation, whose business office is identical with the said Registered Office.
