ARTICLES OF INCORPORATION

ARTICLE I: NAME

The name of this Corporation is Association for the Advancement of Ugandan Americans, Inc., a not-for-profit organization.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and the mailing address of this Corporation shall be located at #150, 500 North Congress Avenue, West Palm Beach, Florida, 33401-2918, in Palm Beach County, Florida.

ARTICLE III: PURPOSES

The specific purposes for which this Corporation is organized are exclusively for educational, social, cultural, economic, and philanthropic purposes as defined by Florida corporate law, and this Corporation's exclusive purpose shall be to promote and either directly or indirectly encourage such endeavors through educational, social, cultural, economic, or philanthropic organizations or conventions.

ARTICLE IV: MANNER OF ELECTION OF DIRECTORS

The Board of Directors shall be elected bi-annually for a term of two years at the annual meeting scheduled for a designated day during the month of May.

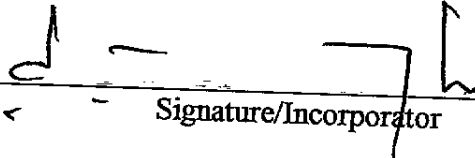
