AMENDMENT TO ARTICLES OF INCORPORATION OF LATINOS UNITED IN ACTION CENTER, INC.

Pursuant to Florida Statute Section 617.1002 and 617.006, the Articles of the Incorporation of Latinos United In Action Center, Inc., a Florida corporation not-forprofit, are hereby amended as follows

- 1. Article III ("Purposes") is amended to add the following language
- A. The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501 © (3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue law.
- B. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 © (3) of the Internal Revenue Code or the corresponding provisions of any future United States Internal Revenue law.
- C. Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 © (3) of the Internal Revenue Code of 1986 or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state or local government for public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction, in the county in which the principal office of the organization is then located, exclusively for such purpose provisions of any future United States Internal Revenue law.

Please correct the name of the treasurer to read Virginia Monegro. The new corporate address is 3321 NW 17th Ave., Mlami, FL 33142. This Amendment to the Articles of Incorporation was approved and adopted by a vote of at least two thirds of the Board of Directors on October 31, 2002. The number of votes cast was sufficient for approval.
