ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF THE 202 HOUSING CORPORATION

Pursuant to Sections 617.1001 and 617.1002 of the Florida Not For Profit Corporation Act, the Articles of Incorporation of THE 202 HOUSING CORPORATION (the "Corporation") are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is THE 202 HOUSING CORPORATION.

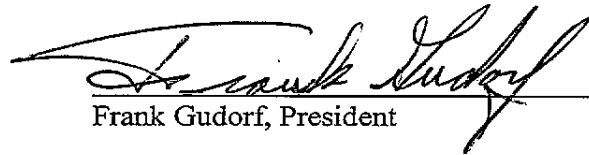
SECOND: Article I of the Articles of Incorporation is amended in its entirety to read as follows:

ARTICLE I. NAME
