ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION FOR SONOMA TOWNHOMES AT DORAL COMMUNITY ASSOCIATION, INC. (A CORPORATION NOT-FOR-PROFIT)

Section 12.3 of the Articles is hereby modified to read as follows:

12.3. Amendments From and After the Turnover Date. After the Turnover Date, but subject to the general restrictions on amendments set forth above, these Articles may be amended with the approval of (i) two-thirds (66 2/3%) of the Board; and (ii) seventy-five percent (75%) of the votes present (in person or by proxy) at a duly called meeting of the Members in which there is a quorum.

FIFTH:

The date of adoption of the amendment was April 5, 2001.

SIXTH: The Amendment to Articles of Incorporation were approved by all of the members entitled to vote on April 5, 2001. This amount was sufficient to adopt the amendment.
