ARTICLES OF INCORPORATION

OF

FACTS ABOUT ALTERNATIVES TO CHEMICAL TRESPASSING, INC.

(a corporation not for profit under
Chapter 617 of the Florida Statutes)

ARTICLE I NAME

The name of the corporation is : Facts about Alternatives to Chemical Trespassing, Inc
Its acronym is: FACT.

ARTICLE II DURATION

The corporation is to exist perpetually.

ARTICLE III PURPOSE

The purpose of the corporation is to promote, preserve or protect the public health and well-being, wildlife and/or environment that may be threatened or affected by toxic chemicals, including (in particular but without limitation) pesticide usage in residential and urban areas.

The corporation's purpose includes (but is not limited specifically to):

- To collect and disseminate scientific information about toxic chemicals, especially pesticides, in the urban environment;
- To collect and disseminate scientific information about the transport of toxic chemicals, especially pesticides, in the air and water;
- To collect and disseminate medical and scientific information about potential health problems associated with toxic chemicals, especially pesticides;
- To educate members, the public, and private and governmental agencies as to the corporation's concerns;
- To investigate alternatives to toxic pest control chemicals, methods and technologies;
- To develop and/or disseminate information about less toxic and nontoxic pest control alternatives and Ecological/Health-Based Integrated Pest Management;
- To educate members, the public, and private and governmental agencies about less toxic and nontoxic alternative pest control chemicals, methods and technologies;
- To work with private and governmental agencies, professional associations and other organizations to reduce the amount of toxic chemicals being used and to substitute less toxic or nontoxic alternatives;
- To act to promote a healthier urban environment, better quality air and water, and safer food.

Notwithstanding any other provision of these Articles, the purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE IV QUALIFICATION OF MEMBERS

Any natural person subscribing to the purpose of the corporation is eligible for membership in the corporation, and shall be admitted as provided in the bylaws. Membership for other persons may be provided for in the bylaws.

At their initial meeting or by written consent in lieu of a meeting, the initial directors named above shall adopt bylaws and elect additional directors to serve on the initial Board of Directors. The initial Board shall serve for a term of 18 months or less. Thereafter the directors shall be elected by the members as provided in the bylaws.

ARTICLE VIII NONPROFIT STATUS

No part of the income of the corporation shall inure to the benefit of any individual, director, officer or member. No shares of stock shall be issued and no dividends shall be paid.

ARTICLE IX POWERS

The corporation shall have all the powers granted corporations not for profit under the laws of the State of Florida. However, notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Revenue Law.

ARTICLE X DISSOLUTION

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or a

corresponding section of any future United States Internal Revenue Law, or shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purposes.
