





**ARTICLE I – EXECUTION**

The undersigned, being all of the original incorporators, hereby execute and acknowledge these Amended Articles of Incorporation, in order to organize and incorporate a business not for Profit, under the Corporate name and at the initial business address:

**ARTICLE II – PURPOSES AND OBJECTS**

The Corporation is formed, pursuant to the Florida General Incorporation Act and to operate exclusively in any manner for such religious, charitable and educational purposes as will qualify it as an exempt organization under section 501(c) (3) of the Internal Revenue Code of 1954, as amended, or under corresponding tax laws covering the distributions to organizations qualified as tax exempt organizations under the Internal Revenue Code, as amended, including private foundations and private operating foundations. Specifically, the corporation will seek to enhance the professionalism of its members and to foster the exchange of business referrals among the members.

**ARTICLE III – DURATION AND NAME**

The duration of this Corporation shall be perpetual. Corporate existence shall commence upon the filing of these Articles of Incorporation, provided that all of the requirements of the law are met. The name of the Corporation shall be Business Referral Group, Inc.

**ARTICLE IV – REGISTERED OFFICE - AGENT**

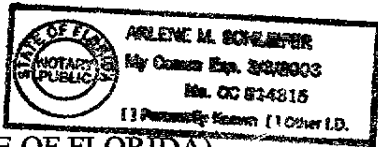
#### **ARTICLE X – GENERAL**




**ARTICLE XI – ACCEPTANCE BY REGISTERED AGENT**






