**ARTICLE VIII
ELECTION PROCESS**

Selection and Election of the Downtown Blues Alliance of the Treasure Coast

At a monthly meeting, a chairperson appoints a nominating committee consisting of one board member, and two other members.

At the next months meeting, the nominating committee shall present a slate of candidates to serve on the Board the following year. Each candidate must be an active member and in good standing.

Determination: Upon receipt of the nominating committee report and approved by the Board, a ballot will be mailed to all active members at least 15 days prior to the following general meeting. The ballots shall be marked in accordance with instructions printed on the ballot and returned to the Downtown Blues Society of the Treasure Coast office within 10 days. One ballot permitted per membership. The Board shall declare, at the next regular general meeting, the candidates with the most votes to be the directors elected.

All newly-elected and appointed Board member shall be seated at the regular following meeting.
