WHEREAS, the Articles of Incorporation, duly filed on March 10<sup>th</sup>, 2000, document number N0000001597, and Article III, Purpose(s) is amended as follows (additions shown by underlining "example of text added"):

The specific purpose(s) for which the corporation is organized is(are):

Exclusively for charitable, education, religious or scientific purposes, within the meaning of section 501(c)(3) of the Internal Revenue Code or corresponding section of any future Federal tax code. More particularly to raise funds in order to restore, transport, maintain and display as a historical monument and bring the Hoga to Fort Lauderdale. If the funds cannot be used for the restoration of the Hoga they will be used for the Naval Air Station, Fort Lauderdale Historical Association, Inc.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future Federal tax code.

WHEREAS, the Articles of Incorporation are amended to add the following Articles:

This corporation shall exist perpetually unless dissolve according to Florida law. 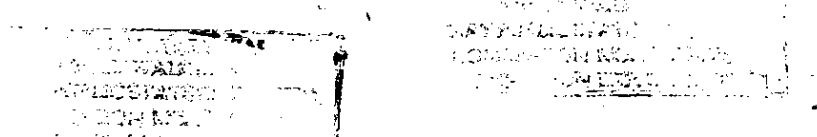


