**ARTICLES OF INCORPORATION  
FOR  
ACTS 29 NETWORK CORPORATION**

**A Florida Not For Profit Corporation**

The undersigned incorporators hereby join together to form a Corporation Not For Profit, pursuant to the provisions of Chapter 617 of the Florida Statutes.

**ARTICLE I**

**NAME**

The name of the Corporation shall be **ACTS 29 NETWORK CORPORATION.**

**ARTICLE II**

**DURATION**

This corporation shall have perpetual existence.

**ARTICLE III**

**PURPOSE**

The purpose of the Corporation shall be for the furthering of the Christian ministry through an association of local churches which have joined together for the purpose of mutual edification and support, and for the planting of new churches.

The Corporation shall also have the authority to ordain people to the gospel ministry, and credential them for this purpose.

**ARTICLE IV**  
**QUALIFICATION FOR MEMBERSHIP**

Membership shall be drawn from those churches that subscribe to the purposes and objectives of the corporation.

**ARTICLE V**

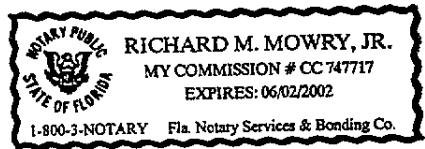


