# ARTICLE I-NAME

The name of this Corporation is Christian Study Center of Gainesville, Inc.

## ARTICLE II-INITIAL PRINCIPAL OFFICE

The street address of the initial principal office of this Corporation is 112 Northwest 16<sup>th</sup> Street, Gainesville,

#### ARTICLE III-COMMENCEMENT AND DURATION

The commencement of this corporation's existence shall be at the time of the filing of these articles of incorporation by the Secretary of State of the State of Florida. This Corporation shall have perpetual existence.

# ARTICLE IV-PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business and shall be operated exclusively for non-profit purposes. No part of the income or assets of the corporation shall be distributed to, or inure to

the benefit of any individual. To operate a student christian study center.

#### ARTICLE V-POWERS


