Pursuant to the provisions of Section 617.1006, Florida Statutes, the undersigned Florida corporation not for profit adopts the following articles of amendment to its articles of incorporation.

**FIRST:** The name of the corporation is Jacksonville Non-Group, Inc.

**SECOND:** Article III should be amended to read:

This is a not-for-profit corporation organized solely for not-for-profit purposes pursuant to the Florida Not For Profit Corporation Act set forth in Chapter 617 of the Florida Statutes. The general nature of the corporation shall be a business league within the meaning of Section 501(c)(6) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States Internal Revenue law (hereinafter referred to as the "Code") and the general object of the corporation is to do all acts and carry on and conduct all activities necessary, suitable, convenient, useful, proper and expedient in connection with and incidental to the accomplishment of any purposes set forth herein or hereafter adopted by the Board of Directors to the full extent permitted by the laws of the State of Florida for corporations not for profit, subject to the restrictions set forth in this Article.

**THIRD:** Articles IV and XII shall be amended by replacing all references to Section 501(c)(3) with Section 501(c)(6).

**FOURTH:** The date of adoption of these amendments was: September 20, 2000.


