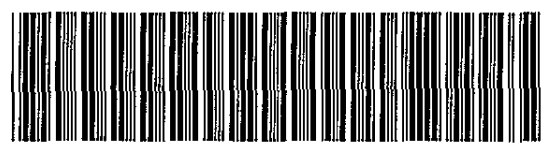

**FIRST:** The name and address of this corporation is **"FLY-BY KNIGHTS" EXPERIMENTAL AIRCRAFT ASSOCIATION (EAA) CHAPTER 1302, INCORPORATED**, a not for profit corporation, 12725 Forest Street, Tampa, Florida 33612.

**SECOND:** The date of the adoption of these Articles of Dissolution is 2 December 2002.
