

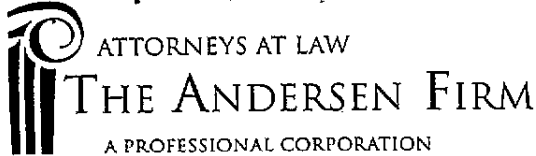



**ARTICLES OF AMENDMENT**  
to  
**ARTICLES OF INCORPORATION**

*Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.*

**FIRST:** Amendments adopted Article VI and Article VII shall be amended to provide the following:

**Article VI** "The affairs of the Corporation shall be managed by a board of directors, which shall consist of not less than (15) Fifteen nor more than (25) Twenty-Five persons. The board of directors shall meet not less frequently than once a year and be elected according to the bylaws."

**Article VII** shall be amended to replace the name "Sandra Roberts" with the name "Sandra Walters."

**SECOND:** The date of adoption of the amendment was: November 12, 2000.


**THIRD:** Adoption of Amendments
