Article I Name: Cocoa/Rockledge Civic League, Inc.

Article II Principal Office: P.O. Box 560491 Rockledge, FL 32956-0491

Article III Purpose: The purpose of the Cocoa/Rockledge Civic League, Inc. shall be to function as a catalyst for the improvement of the political, educational, and social welfare of the community, including, but not limited to: the opposition of racial prejudice of all forms; to serve as a communication medium between the community and local governmental agencies/elected officials; the establishment of programs/projects designed to meet special needs in the community including, but not limited to, voter registration, housing, health, employment, and youth auxiliary; to give special emphasis to the development of leadership in the community; to encourage a greater civic awareness and involvement among members of the community; to protect individual rights and liberties.

Article IV Manner of Election: The Nominating Committee shall be established by September of the election year. The committee shall consist of at least five persons and not more than seven. Two of which should be members of the current Executive Board. The President shall appoint the members of the committee. Four of the Directors shall be elected in October or November of an odd numbered year for a two year term beginning January 1st of the following year and ending December 31st two years later. The Directors are elected by secret ballot. The President appoints two of the Directors to a two-year term. There are a total of six Directors.
