ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF

CALVARY CHAPEL IN CORAL SPRINGS, INC.

*Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida not-for-profit corporation adopts the following articles of amendment to its articles of incorporation:*

FIRST: Amendments adopted:

**ARTICLE III - PURPOSES:** Article III is hereby amended to include as follows:

- (e) This organization is organized and operated exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code.

**ARTICLE VII - POWER LIMITING:** The Articles of Incorporations shall include Article VII to provide as follows:

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

**ARTICLE XI - DISSOLUTION:** The Articles of Incorporations shall include Article XI to provide as follows:

Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.

SECOND: The date of the amendments' adoption is August 8, 2003.
