ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF GRAN PARK AT JACKSONVILLE OWNERS ASSOCIATION, INC. 4 OF GRAN PARK AT JACKSONVILLE OWNERS ASSOCIATION ASSOCIATI

Pursuant to the provisions of Section 617.1002, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

- 1. The name of the corporation is Gran Park at Jacksonville Owners Association, Inc. (the "Corporation").
- 2. The following amendments to the Articles of Incorporation were adopted by the Corporation in the manner prescribed by the Florida Not For Profit Corporation Act:
 - (a) Article I is hereby amended by deletion of the entire text thereof, and by substitution of the following:

"I. NAME AND DEFINITIONS.

The name of this corporation shall be Flagler Center Owners Association, Inc. All defined terms contained in these Articles shall have the same meanings as such terms are defined by the Declaration of Covenants and Restrictions for Flagler Center to be recorded in the current public records of Jacksonville, Duval County, Florida."

- (b) Article VI.A.1 is hereby amended by the deletion of the entire text thereof, and by substitution of the following:
- "1. Each Member, other than the Developer, shall have one (1) vote for each acre, or portion thereof, of each Lot owned by such Member within the Property."
- 3. Pursuant to Section 617.1006(3), Florida Statutes, the members of the Corporation adopted the foregoing amendment on September 27, 2002. The number of votes cast for the amendment was sufficient for approval.
