ARTICLES OF INCORPORATION OF

The undersigned, acting as an incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation of such corporation:

ARTICLE I

NAME: The name of this corporation shall be **Venice Congregation of Jehovah's Witnesses, Inc.**

ARTICLE II

TERM OF EXISTENCE: This corporation is to exist perpetually unless dissolved according to law.

ARTICLE III

CORPORATE PURPOSES: The corporate purposes are:

ARTICLE IV

MEMBERS QUALIFICATIONS: Individuals must be duly baptized and in good standing in the Venice Congregation of Jehovah's Witnesses to be admitted and to remain eligible for membership in this corporation.

DIRECTORS: This corporation shall have three Directors initially. The number of Directors may be modified from time to time by the by-laws adopted by the Shareholders.

ARTICLE VII

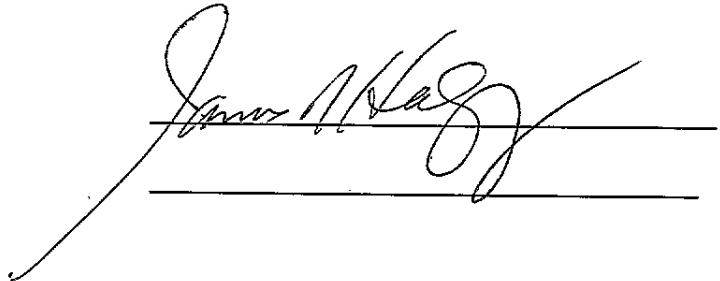
