- ONE: The name and address of this principal corporation is **UNITED YOUTH IN ACTION, INC., 10701 SW 216 ST Suite #13 MIAMI-DADE COUNTY**. The corporation is organized pursuant to the **Florida** Nonprofit Corporation Code.
- TWO: This Corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes to aid disadvantaged youth and their families towards a life of self-sufficiency. The programs will consist of, but shall not be limited to: Literacy, Job Placement, Employment, Tutoring, Counseling, Temporary Shelter, Teenage Pregnancy, Housing and Land Acquisition, Substance Abuse Awareness and Prevention, Aids Awareness and Prevention, and other programs to aid youth in pursuing quantity (length of life) as well as quality of life.
- THREE: The duration of this corporation shall be perpetual. It shall have no stock.
- FOUR: The address of the Registered office is **12552 S.W. 259 Street Naranja, FL. 33023**. The REGISTERED AGENT at the office shall be: *Emily Mathews*

- FIVE: This corporation is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
- (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code.

Any such assets not disposed of, shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
