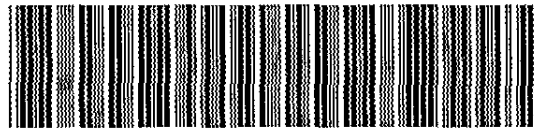

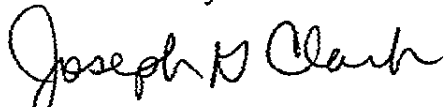

ARTICLE I (Amended)

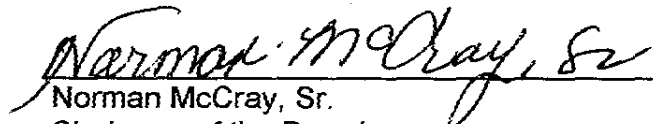
The name of the corporation shall be:
