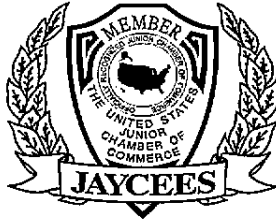

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment(s) adopted: (INDICATE ARTICLE NUMBER(S) BEING AMENDED, ADDED OR DELETED.)

ADDED ARTICLE

Article VIII

In the event of dissolution of this corporation, any residual assets of this organization shall be turned over to Rodeheaver Foundation, Inc., an exempt entity pursuant to section 501(c)(3) of the Internal Revenue Code of 1986. The principal address of Rodeheaver Foundation, Inc., is 601 St. Johns Avenue, Palatka, Florida 32177. Should Rodeheaver Foundation, Inc., also itself be dissolved, said residual assets shall be turned over to another entity, to be determined by the Board of Directors, exempt as described in sections 501(c)(3) or 170(c)(2) of the Internal Revenue Code or corresponding sections of any prior or future Internal Revenue Code.
