BROOKSIDE RESIDENTS ASSOCIATION, INC., the undersigned, hereby make the within Articles of Incorporation for the purpose of becoming incorporated and being a corporation not for profit pursuant to §617 Florida Statutes under and by virtue of the laws of the State of Florida under the following proposed charter:

ARTICLE I - NAME/ADDRESS

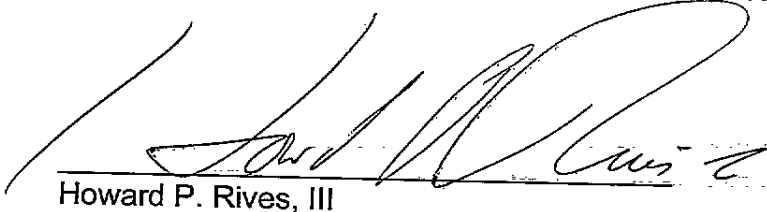
