ARTICLES OF MERGER OF

BOYETTE FARMS HOMEOWNERS' ASSOCIATION, INC. and BOYETTE FARMS ADDITION HOMEOWNERS ASSOCIATION, INC. Florida Corporations Not-For-Profit

Pursuant to Sections 617.1101, 617.1103 and 617.1105, Florida Statutes, Boyette Farms Homeowners' Association, Inc., and Boyette Farms Addition Homeowners Association, Inc., are merged into Boyette Farms Homeowners' Association, Inc. (hereinafter the "Surviving Corporation"), pursuant to the following.

- Associations into the existing Boyette Farms Homeowners' Association, Inc. which shall hereinafter be known as Boyette Farms Homeowners' Association, Inc. The Surviving Corporation will carry out all of the duties and responsibilities required under Chapters 617 and 720 of the Florida Statutes, the Declaration of Covenants, Conditions and Restrictions of Boyette Farms, as recorded in Official Records Book 10416, Page 0165, et seq. and O.R. Book 11612, Page 0111 et seq. and as subsequently amended, and the Declaration of Covenants, Conditions and Restrictions of Boyette Farms Addition as recorded in O.R. Book 13026, Page 0565 et seq., all of the Public Records of Hillsborough County, Florida. The Board of Directors of the Surviving Corporation will adopt new By-Laws. The affairs of the Surviving Corporation shall be managed by a Board of not less three (3) nor more than seven (7) Directors.
- 2. <u>Approval by Boyette Farms Homeowners' Association, Inc.</u> The Board of Directors of Boyette Farms Homeowners' Association, Inc. adopted a resolution at a Board meeting on August

10, 2004, approving the Plan of Merger and directed that it be submitted to a member vote. The special meeting of the members was held on August 10, 2004, wherein the Plan of Merger was adopted by not less than two-thirds (2/3) of the total votes of the members.

- 3. Approval by Boyette Farms Addition Homeowners Association, Inc. The members of Boyette Farms Addition Homeowners Association, Inc. adopted a resolution at a Board meeting on August 10, 2004, approving the Plan of Merger and directed that it be submitted to a member vote. The special meeting of the members was held on August 10, 2004, wherein the Plan of Merger was adopted by not less than two-thirds (2/3) of the total votes of the members.
- 4. <u>Effective Date</u>. The effective date of the merger shall be the date of filing of the Articles of Merger by the Department of State.
- 5. <u>Powers and Authority</u>. The powers and authority of the Surviving Corporation, Boyette Farms Homeowners' Association, Inc. include, but are not limited to, the Association powers enumerated in the original Articles of Incorporation of the Surviving Corporation, Declaration of Covenants, Conditions and Restrictions of Boyette Farms Addition and the Association powers enumerated in the Declaration of Covenants, Conditions and Restrictions for Boyette Farms, all as amended from time to time and the Surviving Corporation By-Laws.
- 6. <u>Articles of Incorporation Amended</u>. The Articles of Incorporation of the Surviving Corporation are amended to the extent provided in the Plan of Merger.


