Upon the dissolution of the corporation, The Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an organization or organizations under Section 501(c)(3) of _the Internal Revenue Code of 1986 (or the future United corresponding provision of any Internal Revenue Law), as the Board of Directors shall determine.
