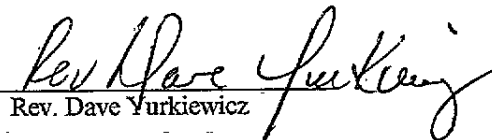

5. To celebrate and perform weddings, baptisms, dedications of children, the sacrament of Holy Communion and any other religious service admissible by the law.

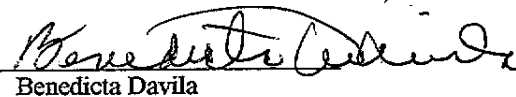

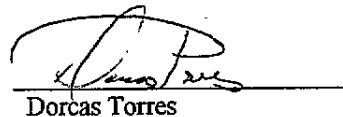

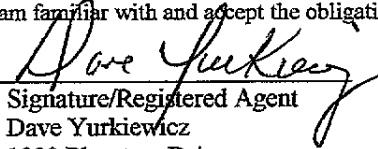
