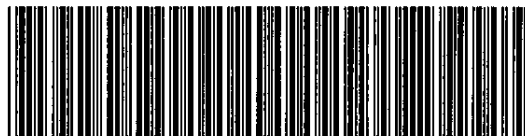

**Articles of Amendment
To
Articles of Incorporation
Of
Management Assistance Program, Inc.**

Pursuant to the provisions of Section 617.006 Florida Statutes 2006, this Florida Not for Profit Corporation adopts the following amendment to its Articles of Incorporation:

1. Name. The present name of the corporation is *Management Assistance Program, Inc.* (the "Corporation").
2. Amendment. Article I of the Corporations Articles of Incorporation is hereby amended so as to read, after amendment, as follows:


"ARTICLE I


NAME

The name of the corporation is *Nonprofit Leadership Center of Tampa Bay, Inc.*"

3. Adoption. This Amendment was adopted, in accordance with the bylaws of the Corporation, by a majority of the directors of the corporation at a meeting held November 3, 2006.
4. Effective Date. This Amendment shall become effective upon filing of these Articles of Amendment with the Secretary of State of Florida.
5. Voting. The board of directors comprises the sole class of members of the Corporation.
