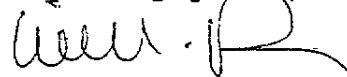

ARTICLES OF INCORPORATION
OF
THE ORGANIZATION FOR PROFESSIONAL ASTROLOGY, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a not-for-profit corporation under the laws of the State of Florida.

ARTICLE I. NAME AND ADDRESS

The name of the corporation shall be:

THE ORGANIZATION FOR PROFESSIONAL ASTROLOGY, INC.

The principal place of business and mailing address of this corporation shall be:

Naples, Florida 34101

ARTICLE II. NATURE OF BUSINESS

This is a not-for-profit corporation, organized solely for general charitable purposes pursuant to the Florida Corporations Not for Profit Law set forth in Section 617 of the Florida Statutes, and permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. DURATION

This corporation is to exist perpetually.

ARTICLE IV. GENERAL AND SPECIFIC PURPOSES

The specific and primary purposes for which this corporation is formed are:

A. For the advancement of charity, education and any other related or corresponding charitable purposes by the distribution of its funds for such purposes.

B. This corporation shall not be organized for the pecuniary or business profit of its members, directors, officers or any other individuals connected with this corporation. This shall not prohibit any member, director, officer, or other individual connected with the corporation from being employed by the

corporation for reasonable services at a reasonable rate of compensation.

C. To acquire by gift or purchase, hold, sell, convey, assign, mortgage, or lease any property, real or personal, for said charitable purpose as the Board of Directors in their discretion may determine.

D. To borrow money and to issues evidence in the furtherance of any of the objectives of its business, and to secure loans by mortgage, pledge, deed of trust or other lien.

E. To engage in any kind of activity and to enter into, perform and carry out contracts of any kind necessary or in connection with or incidental to the accomplishment of any or more of the non-profit purposes of the corporation.

F. To operate exclusively in any other manner for such religious, charitable and educational purposes as will qualify it as an exempt organization under Section 501 (c) (3) of the Internal Revenue Code of 1954, as amended, or under any corresponding provisions of any subsequent federal tax laws, covering the distributions to organizations qualified as tax exempt organizations under the Internal Revenue Code, as amended, including private foundations and private operating foundations.

ARTICLE V. MEMBERS

The membership of this corporation shall constitute all persons hereinafter named as subscribers and such other persons as from time to time hereafter may become members in the manner provided in the Bylaws.

ARTICLE VI. DIRECTORS

The method of the election or appointment of the Directors shall be provided in the Bylaws of the corporation.

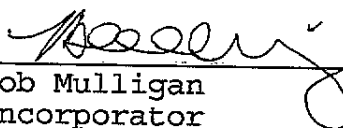

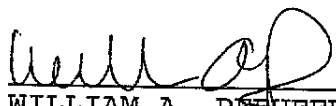
