**ARTICLES OF INCORPORATION**

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation not for profit under Chapter 617, Laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation not for profit.

**ARTICLE ONE**

**NAME OF CORPORATION**

The name of the corporation shall be RIVER OF LIFE MINISTRIES INTERNATIONAL, INC.

**ARTICLE TWO**

**GENERAL NATURE OF BUSINESS**

The general nature of the business to be conducted by River of Life Ministries International, Inc., shall be a Christian Ministry to:

- A. Govern its corporate body;
- B. Acquire and Dispose of real and personal property;
- C. Worship, Fellowship, and Propagate the Gospel of Jesus Christ;
- D. Cooperate with other ministries in the body of Christ;
- E. Recognize ministry giftings within the local body of believers.
- F. The ministry shall also conduct such other ministries as the pastor and

elders deem necessary including the ordination of ministers, recognizing members that walk in the fivefold ministry, and supporting missionaries.

**ARTICLE THREE**

**MEMBERS**

The qualifications for members and the manner of their admission are as determined by the by-laws.

**ARTICLE FOUR**

**VOTING RIGHTS**

Each member shall be entitled to one vote at corporate meetings.

**ARTICLE FIVE**

**INCOME DISTRIBUTION**

No part of the income of this corporation shall be distributed to its members, except as compensation for services rendered or as reimbursement for expenses incurred.

**ARTICLE SIX**

**EXISTENCE**

This corporation shall exist perpetually unless dissolved according to law.

**ARTICLE SEVEN**

**PRINCIPAL PLACE OF BUSINESS**

The initial principal place of business of this corporation is 4436 Clinton Street, Marianna, Florida 32446, and the mailing address is P.O. Box 146, Marianna, Florida 32447.

**ARTICLE EIGHT**

**REGISTERED OFFICE AND REGISTERED AGENT**

The street address of the initial registered office of the corporation is 4436 Clinton Street, Marianna, Florida 32446, and the name of its initial registered agent at such address is Charles M. Wynn.

**ARTICLE NINE**

**NUMBER OF DIRECTORS**

The business of the corporation shall be conducted by a Board of Directors which shall consist of not less than three (3) persons nor more than seven (7), as shall be designated by the By-Laws, and elected at the annual meeting.

The By-Laws of River of Life Ministries, Inc., shall be adopted by the Board of Directors and may be altered, amended to rescinded in the manner provided by the ByLaws.

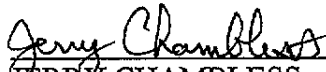

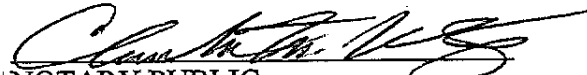
