

The State of Florida is pleased to introduce the new online vendor registration system. This secure online system will allow you to register and update your file, ensuring that state agencies have the most updated information about your business and the products and services you provide. Using this new system, state agencies will have the capability to match available <u>contracts</u> to the vendors that provide the requested service or commodity. The State can then track which vendors compete for the contracts, who "wins" the contracts, and how much money is expended. This information is also essential in <u>payment</u> for services rendered to the State – so it is very important that your remittance data is correct.

How to Register

In order to register, you will need to have the following available:

- Your Federal Employer Identification Code (FEID) or Social Security Number (SSN)
- Your Florida Department of Revenue identification number

(This number is your Florida sales tax certificate of registration number. If you do not have an assigned number, it is not a required field and can be left blank on the registration form.)

Your State of Florida PIN number

To begin the registration process, log in to the State's web site — www.state.fl.us — and click on the "Vendor Registration System" logo. Then follow the instructions on the screen. Registration should take approximately 5 minutes to complete. All screens must be filled out in order to fully update your records and ensure your eligibility for future state contracting opportunities. If you need assistance or do not have online access, please call our toll-free Vendor Registration Hotline at 877/209-2760. This Hotline service will be available until March 31, 2000. Beginning April 1, 2000, you may call the SPURS Help Desk at 850/921-0997 for assistance.

Your registration will automatically update your existing corporate information maintained in the State Purchasing System (SPURS) Vendor File, which in turn, updates the Comptroller's vendor payment files. REMEMBER ALL VENDORS WHETHER NEW OR EXISTING MUST REGISTER ONLINE BY MARCH 31, 2000. Failure to do so could slow down contract awards and access to new opportunities, compromising your contracting potential with the State of Florida.
